EDMONDS COMMUNITY COLLEGE FEDERATION OF TEACHERS LOCAL 4254, AFT, AFL/CIO

CONSTITUTION

Preamble

We, the membership of the Edmonds Community College Federation of Teachers, commit ourselves to the following propositions: that the Edmonds Community College Federation of Teachers is a union, part of the labor movement; that, as a union, we shall pursue the professional interests of the faculty through collective bargaining, grievance, and employee action; that, as a union, we shall seek to secure the rights of academic freedom and tenure; that, as a union, we shall endeavor to eliminate within education all forms of racism, as well as all other forms of discrimination; that, as a union, we shall cooperate with all legitimate organizations which advance democratic principles at all levels of education; and that, as a union, we shall dedicate ourselves to the democratic traditions and practices of the American Federation of Teachers.

Article I. Name.

The name of this organization shall be the Edmonds Community College Federation of Teachers, chartered as a Local 4254 by the American Federation of Teachers, AFL-CIO, and known as the Federation.

Article II. Affiliations.

The Federation shall maintain affiliation with and whenever possible send delegates to the following organizations: The American Federation of Teachers, AFT Washington, the Snohomish County Labor Council, and the Washington State Labor Council. Other affiliations may be determined by the Executive Council.

Article III. Membership.

Section 1. All instructors, librarians, media-specialists, counselors and others specialized personnel designated as eligible in the Bylaws are eligible for active membership.

Section 2. Associate membership shall be open to retired members, members on unpaid leaves of absence, and members who withdraw from the profession for research or other pursuits and who want to maintain affiliation. Associate members may attend general membership meetings and have the right to the floor therein, but shall not have the right to vote or hold office in the Federation.

Section 3. No discrimination shall ever be shown toward individual members or applicants for membership because of race, religious faith, or political activities or belief.

Article IV. Finances.

Section 1. Changes in dues shall be fixed by a majority vote of members present at any regular meeting providing written notice of contemplated change in dues has been announced to members thirty (30) days prior to that meeting. Within fifteen (15) days of that meeting, the proposed change shall be submitted by written ballot to the entire membership. Upon passage by a majority of the ballots cast, the change in dues shall be implemented.

Section 2. Additional finances may be obtained by various fund raising activities.

Section 3. Assessments for emergency expenditures shall be set by the Executive Council subject to ratification by a majority of the membership.

Article V. Elected Officers.

The officers of the Federation shall be a president, a vice-president for membership, a vice-president for communications, a vice-president for adjunct faculty, a vice-president for FAR council, a vice-president for political action, a vice-president for grievance, a vice-president for contracted programs, a secretary, and a treasurer. These officers shall constitute the Federation's Executive Council.

Section 1. Each officer shall be elected for a term of two years.

Section 2. The election of officers shall be conducted according to the procedure set forth in the Bylaws of this Constitution.

Section 3. Recall of any officer may be accomplished by a two-thirds vote of the membership.

Section 4. Vacancies occurring between elections shall be filled by a member appointed by the Executive Council, except that when a vacancy occurs in the office of President, a special election shall be held.

Article VI. Committees.

Section 1. Standing committees shall be established by the Executive Council. The names and functions of standing committees shall be as set forth in the Bylaws.

Section 2. Ad hoc committees shall be established by the Executive Council.

Section 3. Chairpersons and members of the standing committees, of the contract committees, and of all <u>ad hoc</u> committees shall be appointed by the President with the consent of a majority of the Executive Council.

Article VII. Amendments.

This constitution, with the exception of this article, may be amended by a two-thirds vote at any membership meeting of the Federation, provided that notice of the proposed amendment,

with copy thereof, was in the call of the meeting, and provided also that the amendment was published to the membership not less than ten (10) days prior to the meeting.

Article VIII. Rules of Order.

<u>Robert's Rules of Order, Revised</u> shall govern in all cases not covered by this Constitution or by the Bylaws of this Federation.

Article IX. Availability of Constitution.

Section 1. Three copies of this constitution and all future amendments shall be submitted to the national headquarters of the American Federation of Teachers.

Section 2. Copies of this constitution shall be available for all members of the Federation upon request to the Secretary.

Section 3. Copies of this constitution shall be made available to other affiliated organizations upon request.

Article X. Enabling Article.

Ratification will be determined by a written ballot, and this Constitution shall become effective when approved by a majority of the ballots cast.
